All NAR members, including appraisers, are required to complete a minimum of 2.5 hours of REALTOR® Code of Ethics training during each cycle. If you have not yet completed your ethics training, consider attending *Mandatory Ethics & Local Association Training* on **January 27th, 9am-1:15pm**. Only \$20 for GSAR members/\$60 for non-members (4 hours CE).
