

# New York State Real Estate Education Foundation Scholarship Rules and Application

Application deadline: July 31 or December 31 (limit one per year)

# Mission/Purpose

Through its scholarship program, the New York State Real Estate Education Foundation (NYSREEF) aims to raise the level of knowledge, professionalism and client service among those in the real estate profession by encouraging participation in approved courses.

# Eligibility

Any individual who has at least one year experience in real estate sales and/or related disciplines, who is licensed and actively practicing in New York State and who holds primary REALTOR® membership in New York State is eligible. Applicants must:

- Demonstrate a drive to continue their real estate education,
- Show positive production results with consistent growth, and
- Prove their interest in furthering their career in real estate or real estate education.

# **Application Requirements**

\_\_\_ Completed applications must be sent by July 31 or December 31. *Incomplete or unsigned applications will not be considered. Only one application per year will be considered.* 

\_\_\_\_ Two letters of recommendation supporting the applicant must be included and must have been written within the previous three months. Recommendations must include one from the broker or manager of the firm with which the applicant is associated; the other from someone else familiar with the applicant professionally (such as a local board officer, a community or civic organization leader or other professional). If the applicant is a broker, two professional recommendations will be accepted.

\_\_\_\_ Applicants must attach a letter providing information about why this particular scholarship is needed (although scholarship awards are not based solely on need, you may address any existing financial hardship), plans for use of the scholarship, how it will assist in your career development, and your future goals relating to the use of the scholarship. A statement of community involvement, local board activities and any other information that might aid in the selection process may be included in your letter.

- Graduate REALTOR® Institute designation courses
- Military Relocation Professional certification course

- Other National Association of REALTORS® or NAR affiliates' educational programs
- Instructor Training Institute (Maximum allowable amount is half of ITI tuition.)

Applications will be reviewed and awards announced by the Board of Directors of NYSREEF twice a year, in March and October.
